- 4.2 The total strength of the Board shall not be less than two members and shall not be more than ten members at any time. The Members of the Board shall have the right to Co-opt one or more persons as Member of the Board of Trustees to fill any vacancies, for such periods as they deem fit, within the limits of the size of the Board as aforementioned. A retiring Member shall be eligible for reappointment.

- 4.6 A Trustee shall forfeit his Trusteeship position in the Trust in the event of his death, voluntary retirement, or dismissal, as also when adjudged insolvent, or of unsound mind, or convicted any offence involving moral turpitude, or consecutive absence without leave of absence from three Board Meeting of the Trust. A Trustee, other than life member, may be dismissed or his services terminated from the Trusteeship position by the Board of Trustees, particularly, if he states or it is proved that he does not believe in the aims and objective of the trust, or he attempts to subvert, or subverts the activities of the Trust, or engages himself in any acts which are prejudicial to the interest of the Trust.

5.1.24.
